Remove Device

Peel the blister pouch and remove device. (Do not touch needle protector.) Grasp sheath using the plastic peel pouch. To prevent contamination, do not to touch the Needle-Pro[®] EDGE[™] safety device's Luer connector. [fig 1]

2 Administer

With needle bevel up [fig 2] pull the needle cap straight away from the needle to remove it. **Draw up medication**. Express air and administer medication.

3 Engage + Confirm

Engage the Needle-Pro® EDGE™ safety device using a one-handed technique by gently pressing the sheath of the needle protection device against any flat surface. DO NOT use your free hand to press the protective sheath over the needle. As the sheath is pressed, the needle firmly engages into the sheath with an audible click. [fig 3a and 3b]

Visually confirm that the needle is fully engaged into the needle protection sheath. Dispose of the entire device in an approved sharps container immediately after engaging the safety feature


4 Alternate Technique

If the clinical procedure requires use of a two-needle technique (one needle to draw up medication and a second to administer it), remove the engaged Needle-Pro[®] EDGE[™] safety device from the syringe with an easy twisting motion after drawing up the medication. Grasp the base of the needle hub with your thumb and forefinger while twisting, keeping your other fingers clear of the end of the safety device. [fig 4]

5 Dispose + Repeat

Dispose of the engaged device [fig 5] and select a second needle with the Needle-Pro[®] EDGE[™] safety device.

After attaching a new needle with the Needle-Pro[®] EDGE[™] **safety device to the syringe, repeat all necessary steps above with the second needle**. Dispose of the entire device immediately after engaging the safety feature.
